- If the Court has set a limit for withdrawal from the Account by the legal guardian or custodian, the legal guardian and/or custodian must disclose the information to the Bank immediately and shall be so bound accordingly. No one except the minor's father or legal guardian may make withdrawals from the minor's account without first providing the Bank with a letter of no objection from the minor's father or legal guardian.
- The Account shall be subject to the rules of Islamic Sharia and the applicable civil and commercial laws in the State of Qatar.
